Hector Rodriguez Joins Dallas Sidekicks Ownership Group Hector "H3CZ" Rodriguez, founder and CEO of OpTic Gaming, has joined the ownership group of the Dallas Sidekicks, a professional indoor soccer team. This move aims to merge the excitement of indoor soccer with the dynamic world of gaming and esports. Rodriguez had previously regained full ownership of OpTic Gaming in 2020 after selling it to Immortals Gaming Club in 2017 for \$100 million. He then merged OpTic with Envy Gaming Team Changes: A Look at What's Happening to the Esports Organization OpTic Gaming, a well-known and successful esports organization, has been undergoing significant changes in recent months. The team, which is owned by OpTic Gaming, has seen several high-profile player departures and roster changes. One of the most notable departures was Bobby Poff, who left the team after two years citing inability to agree on a new deal. Poff, also known as Bobby Poff, had previously played for Envy Gaming before joining OpTic Gaming. Another player to leave OpTic Gaming is Dashy, who was dropped from the team due to ongoing attitude problems. The team confirmed this in a recent episode of the OpTic Podcast. iLLeY, a member of the OpTic Texas Call of Duty roster, has also announced that he is a free agent after being restricted by the organization. iLLeY won a world championship with the Dallas Empire in 2020 and was a valuable asset to the team. OpTic Gaming's Valorant team was also forced to forfeit a match against Minnesota ROKKR due to financial troubles and inability to secure a coveted NA franchise spot for the 2023 season. The organization has undergone significant changes in recent years, including a merger with Envy Gaming. The two North Texas esports brands merged in November 2021, but the Envy Gaming is now the dominant brand, having acquired the Envy Gaming name and assets. OpTic Texas replaced iLLeY with Daniel "Ghosty" Rothe, a 20-year-old Call of Duty Challengers player. This marks the second recent roster change for the team, which previously lost veteran Seth "Scump" Abner to retirement. OpTic was founded by Hector Rodriguez in 2006 and has since become one of the most successful gaming organizations, even being sold to Immortals Gaming Club in a reported \$100 million deal in 2017. However, Rodriguez reacquired the rights to the organization's name in 2020. OpTic Gaming's New Era: H3CZ Returns as CEO Hector "H3CZ" Rodriguez and OpTic KR3W. Neil Leibman and H3CZ own this company. Envy gaming bought out the OpTic brand in 2021. Hecz purchased the branding, partnered with NRG, then merged with Envy/Dallas Empire to form OpTic Texas. H3CZ explains why he sold OpTic and buys it back! Hecz joined Dallas Sidekicks' ownership. The new CEO of OpTic Gaming is Allen's gaming and media entrepreneur Hector Rodriguez. He bought out OpTic for an estimated \$100 million, retaining the Los Angeles Call of Duty League spot. OpTic Gaming made over \$25m in 2022. They earned over \$3.5 billion, a significant increase of 46% since December 2020. TSM remains at the top spot, but 100 Thieves have experienced the most substantial growth among the top teams. FaZe Holdings' market cap plummeted by -92.93% within one year, settling at \$13.74 million as of November 10, 2023. The average annual pay for an Optic Gaming employee in the United States is a substantial \$147,264 per year, as of November 3, 2023. Notable Call of Duty player Seth "Scump" Abner has announced his immediate retirement from OpTic Texas, contrary to previous statements. Matthew "Nadeshot" Haag, co-owner of 100 Thieves and former OpTic Gaming member, is one of the most renowned players in Call of Duty history. Hector Rodriguez, also known as "HECZ," regained full ownership of OpTic Gaming on November 11, 2020, after acquiring the rights back from Immortals Gaming Club. This deal marked a significant changes. In 2020, the team was sold to Immortals Gaming Club in a reported \$100 million esports deal. A year later, OpTic merged with Envy Gaming, forming the current company. The reasons behind OpTic's split remain unclear but likely involved their inability to secure a NA Valorant franchise spot for 2023. The team lost its star player Scump due to reported rivalry issues with Nadeshot. After Scump joined Team EnVyUs, OpTic formed OpTic Texas, marking the end of their partnership with NRG esports. However, it's unclear if OpTic owns Dallas Empire as they are based on a parent company. OpTic's roster has experienced several departures, including ZLaner and Dooplex, both citing personal reasons such as health concerns and managing schedules. The team is known for its revenue from various esports activities, but it's unclear how "play to earn" games and NFTs are integrated into their operations. The Dallas Empire's 2020 world champion, iLLeY, is still waiting for an announcement about his next move. Matthew "FormaL" Piper, a former professional Call of Duty. Meanwhile, the NA Valorant franchise spot for 2023 slipped through OpTic's fingers, forcing them to let go of their talented roster. A recent documentary sheds light on what went wrong, offering insights from players and staff. In another blow, OpTic Texas forfeited a match against Minnesota ROKKR. To make matters worse, the team merged with Envy Gaming after financial troubles plagued its rapid expansion following a change in ownership. Now, as part of the merger, Envy Gaming has rebranded itself as OpTic's roster changes continue, with Daniel "Ghosty" Rothe replacing iLLeY. This is not the only recent shift, as veteran Seth "Scump" Abner retired last month. Hector Rodriguez, a YouTube star and owner of OpTic Gaming, has seen his net worth soar to \$5 Million thanks to his online presence and gaming ventures. Hector Rodriguez has not been linked to any notable individuals as his partner. He has been featured in several lists of popular YouTube stars and famous people born in Cuba. As of December 1, 2023, there is no record of him being in a relationship.
